

Fall 2011 Tuition Installment Plan Agreement for xxxxxxxxxxxx

Finance Charge: \$25.00
(The dollar amount the credit will cost you, including all fees.)

Amount Financed: \$207.50
(The amount of credit provided to you or on your behalf.)

Total Payments: \$232.50
(The amount you will have paid after you have made all payments as scheduled.)

You have the right to receive at this time an itemization of the Amount Financed. Would you like to see your plan's Budget Worksheet?

If you pay your plan off early, you will not have to pay a penalty and you will not be entitled to a refund of part of the setup fee.

Installment Plan Agreements are between a student and Collin College and should be completed by the student, and the student must be at least 18 years of age. Please Note: If the student is not 18 years of age, call the Cashier's Office for further instructions. I, xxxxxxxxxxxx, hereby agree as stated in this agreement to pay the Installment Plan deferred balance in 2 installment payments on or before the due dates specified for each installment. The installment payments are in addition to the 50 percent of the total amount due and the non-refundable payment plan service charge of \$25.00 due upon agreement initiation. I understand INSTALLMENT AMOUNTS MAY CHANGE over time as a result of new charges, payments, and/or financial aid adjustments; and that should courses be added, 50% of the additional course enrollment tuition and fees will be due and payable upon the date of enrollment with the remaining balance incorporated into the installment payment amounts. I also agree to pay the payment plan setup fee of \$25.00. I understand that a \$25.00 late fee will be assessed for each installment payment that is late. I also understand failure to meet the terms of this agreement may entitle Collin County Community College District to (1) declare the full balance plus interest, Annual Interest Rate of 6% per annum on matured/unpaid balance, due and payable by law, (2) may remove students for non-payment from registered courses and deny credit for work completed, (3) deny future enrollment in installment plans, (4) retain all degrees, awards, and records to which I might be otherwise entitled until the unpaid balance, as well as all attorney fees, legal expenses, and other collection costs are paid in full. I understand that should I withdraw from the College, the full amount due shall at once become due and payable. I understand I may pay the outstanding balance in full or in part prior to the due date without any prepayment penalty.

First Installment in the amount of \$103.75 due on 09/15/2011.
Second Installment in the amount of \$103.75 due on 10/13/2011.
