  - \* Concerns regarding the Literature requirement for the AA degree: Currently, one additional sophomore Literature course is required for the degree. Could a student take a Literature course as an alternative to the Computer Literacy and also complete the AA degree requirement, thus "double dipping"?
  - \* Another question involved the transferability of the Mexican-American history course.
  - \* Questions were also raised about the large number of alternative courses listed.
