Matt Coulter called the meeting to order.

SACS (Southern Association of Colleges and Schools) – Tom Martin and Sherry Schumann gave an overview and background information on concerns and issues regarding SACS accreditation requirements and substantive changes. It is important for the CAB to be aware of these requirements and to ask questions when programs and courses are proposed.

Discussion

- ◆ CAB and the Core Curriculum – Matt asked that members continue to review the previous core document reflecting four perspectives for further discussion. At that time, we will forward any recommendation(s) to GEO Forum and Vice President Mary McRae. He will also try to obtain further definition of the CAB's role.
- ◆ Academic Certificates – A proposal was presented to create two certificates: Core Complete Certificate and Field of Study Certificate. These certificates would increase significance and visibility for students and will increase completers in these areas. Following discussion and a majority vote, the certificates were recommended.

Deans' Liaison Report – Bill Blitt

- ◆ Dual Credit (DC)
 - * DC will remain in Student Development, and the various concerns and issues that have been raised will be reviewed.
 - * High schools will not make decisions regarding curriculum; it will be done by Collin faculty.
 - * The possibility of housing PISD DC classes at Collin facilities is being reviewed. This would resolve many of the issues that have been discussed. DC classes could be scheduled early morning or later in the afternoon, so that classroom availability and parking would not be a problem.
- ◆ Philosophy Courses (PHIL1316 & 1317) – These courses will not be added to the core at this time. GEO Forum 2 will involve a complete review of current core courses. Each disciplinary area will have an opportunity to look at their courses. This will be the process instead of adding courses "piece-meal".
