- PLA Advising Form
 - Suggested Additions:
 - Add the ability to list all stackable credentials
 - Add note that any changes in award declaration will impact eligibility to apply the PLA credit
 - Add note that transfer of credits is not guaranteed
 - Add note to ensure testing center has applied other potential credits (like AP and IB)
 - Add disclosure that this is for planning purposes and doesn't signify final credit earned; students should confirm with advising with what is officially transcripted on the students account.

 - Rename as "Advising Worksheet"
- General Concerns:
 - Many members discussed concern with signature approvals. There were concerns that the signature my incorrectly signify that the plan represents transcripted credits.
 - Members expressed concern for students who may apply PLA for one award, but then may change awards to a shorter award and then have too many credits and no longer be eligible to be awarded the shorter award.
- PLA Board Membership
 - Structure & Terms, Chair-Elect, CAB Liaison
 - Chair and Chair-Elect will work with the curriculum office to draft up a plan for staggering the end
 of terms and revised procedures for the PLA Review Board
 - Can the Chair-Elect be a Workforce Program Coach? The curriculum office will follow up on this question.
 - Members agree that a three-year term for members is appropriate.
 - Question needing follow up, can the CAB liaison be a director from the PLA Review Board?
 Currently, there isn't anyone who is on both CAB and the PLA Review Board. Instead, Donna Smith has volunteered to serve as a CAB liaison since directors are invited to the CAB meetings already.
 - Members discussed the PLA Committee; there is no longer a need for the committee and the members suggested it is time for the committee to be dissolved.
