Meeting Minutes

March 23, 2004

The Collin County Community College District conducted its regular monthly Board meeting on March 23, 2004 in Rooms A112 and the Spokes Student Lounge at the Preston Ridge Campus, 9700 Wade Boulevard, Frisco, Texas 75035 with Chair Sam Roach presiding. Trustees in attendance were Dr. Boon, Dr. Collins, Mrs. Goodell, Mr. Trujillo, Mr. Hendricks, Mr. Justice, and Mrs. Bauge. Trustee Cargo was absent. Also, present were College President Cary A. Israel, CCCCD faculty, students, staff, community members and vendor representatives.

CALL TO ORDER

Chairman Roach called the March 23, 2004 meeting of the Board of Trustees of Collin County Community College District to order at 6:00 p.m. The Board met at the Preston Ridge Campus, 9700 Wade Boulevard, Frisco, Texas, 75035. The Board recessed to closed session in Room A112 as authorized by Article 551.001, Texas Government Code.

OPEN SESSION

Chairman Roach reconvened the meeting at 7:28 p.m. in the Spokes Lounge of the Preston Ridge Campus. He welcomed those in attendance saying that it is good to hold the meetings at the various campuses and see the progress of construction projects such as those currently underway at the Preston Ridge Campus. He called on Shirley Harmon to certify posting of the notice of the meeting.

CERTIFICATION OF THE NOTICE OF THE MARCH 23, 2004 MEETING OF THE CCCCD BOARD OF TRUSTEES

Mrs. Shirley Harmon certified the notice of the March 23, 2004 CCCCD Board of Trustees meeting was posted according to Article 551.001 of the Texas Government Code.

APPROVAL OF THE MINUTES OF THE FEBRUARY 24, 2004 CCCCD BOARD OF TRUSTEES MEETING

A motion by Mr. Trujillo, seconded by Dr. Collins, to approve the February 24, 2004 minutes was unanimously approved as presented in public hearing.

PRESENTATIONS

Preston Ridge Campus Construction Update - DalMac Construction

Bob McMinn from DalMac Construction gave a brief pictorial update of construction at the Preston Ridge Campus. Concrete is set and the steel is up on the LRC facility and they are ready to pour slab on the Music Hall. In response to questions from Trustee Justice, Mr. McMinn reported that the project still has a targeted completion date of late November or early December and that no structural changes have been made to the original plan.

Presentation by Judge Ron Harris

Judge Ron Harris discussed Governor Perry's proposed cap on property tax appraisal increases and urged Trustees to oppose the proposal. He recently met with the five largest cities and school districts

in the area and said they are firmly united in opposition to the proposal. Judge Harris said that the Commissioner's Court views the proposal as a disaster to the county that could result in the loss of four to five million dollars a year. A press conference will be scheduled for late next week or early the following week to show a united front in opposition and Judge Harris asked for the college district's support in this effort. Chairman Roach and President Israel responded that the issue is not on the Board's agenda and could not be considered at this time. President Israel said that if the Board considers opposition to the proposal it would phrase its position as it pertains to the college district.

Public Service Announcement for Monopoly on Ice

Vernon Hadnot of CCCCD's Media Services presented a 30-second public service announcement for Monopoly on Ice. The announcement focuses on the success of the March 19 event that raised more than \$180,000 for student scholarships. President Israel said the college district plans to utilize this type of quick-paced, concise-format video for other public service announcements. Chairman Roach thanked Mr. Hadnot for a good job in developing the announcement.

President Israel commented on the quality and scope of the qualifications of faculty under review for multi-year contracts. Dr. Toni Jenkins, Executive Vice President, and Dr. Sheryl Kappus, Vice President Academic Affairs, presented faculty for the board's consideration. Dr. Jenkins said it was her pleasure to recommend four faculty members for multi-year contracts. She said the faculty are versatile in the field of Engineering Technology and can teach across the many areas of the discipline. They stay current to the changes in the discipline and are active in their communities. Dr. Kappus presented 34 faculty members for approval of multi-year contracts. President Israel presented a request from the Farmersville Historical Society, a 501 (c) 3 organization, for a 2004 tax abatement on the Bain-Honaker House in Farmersville, Texas. The House will be used as a museum and meeting faculty.

On motion of Dr. Collins, seconded by Mrs. Goodell, the 2004 tax abatement for the Bain-Honaker House, 100 College Street, Farmersville, Texas, was unanimously approved as presented in public hearing.

2004-3-5 Approval of Board Policies

BE IT RESOLVED, at the recommendation of the President, the Collin County Community College District Board approves the policies presented for second reading.

The policies were presented for first reading at the February 24, 2004 board meeting. President Israel noted one change to the policies presented for approval. Section BD (Local), SPECIAL OR EMERGENCY MEETINGS, 3rd paragraph, should read, "The Chairman of the Board shall call an emergency meeting when the Chairman of the Board or two members of the Board determine that an emergency or urgent public necessity, as defined by law, warrants the meeting." This revision changes from four to two the number of board members required to make the determination to call an emergency meeting.

On motion of Mr. Justice, seconded by Mrs. Goodell, the Board of Trustees unanimously approved the board policies as presented in public hearing.

2004-3-6 First Reading Board Policies

Chairman Roach and President Israel discussed the first reading of board local policies proposed by the Texas Association of School Boards (TASB) Policy Service. Chairman Roach said time has not allowed a thorough review by the board, administration, and faculty of the many policies presented. President Israel recommended to the Board of Trustees that the policies be reviewed over time and in appropriate forums so that thorough input and consideration could be given to each policy. No board action was required or taken.

2004-3-10 Approval of Increases to Annual Agreements w/ Development Dimensions International (DDI), Education to Go, and Dental Careers Foundation

BE IT RESOLVED, at the recommendation of the President, the Board of Trustees of the Collin County Community College District approves the following requested increases to the annual agreements with Developmental Dimensions International (DDI), Education to Go, and Dental Careers Foundation—Wayne Goodowitz.

<u>Developmental Dimensions International (DDI)</u>

Increase the annual agreement with DDI to a revised estimate of \$55,000.

Education to Go

Increase the annual agreement with Education to Go to a revised estimate of \$46,500.

Dental Careers Education—Wayne Goodowitz

Agreement amended from \$140,000 to a revised estimate of \$215,200.

President Israel said DDI is a major international consulting firm providing work force development. CCCCD will be the first college in the United States to provide on-line courses with DDI. Education to Go is an on-line computer training partner. They have approximately 1,300 domestic and international partners and CCCCD is among their top 10. Dental Careers Foundation is a dental assisting training program provider. The requested increase is based on the increased demand for dental assisting training classes.

On motion of Dr. Boon, seconded by Dr. Collins, the Board of Trustees approved the requested increases to the annual agreements with Development Dimensions International (DDI), Education to Go, and Dental Careers Foundation—Wayne Goodowitz as presented in public hearing.

2004-3-11 Approval of Expenditure Reports

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of the Collin County Community College District approves the Expenditure Reports for March 2004.

Upon motion of Mr. Justice, seconded by Mr. Hendricks, the Board of Trustees unanimously approved the Expenditure Reports for March 2004.

In response to a question from Mr. Justice, President Israel said that the majority of lawn maintenance costs were labor and show up under "contract services" in the expenditure report. However, not all of the expenses in this line item are for lawn maintenance, it also includes office or other support services. Mr. Justice said that in the past CCCCD had utilized some of Sheriff Box's trustees for these services. Mr.

Hall said the trustees were utilized on a one-time basis to clean the creek area at the Central Park Campus. President Israel said that he would look into shared services with other entities in order to keep the college district's costs down.

2004-3-12 Approval of Bid Report

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of the Collin County Community College District approves the Bid Report for March 2004.

Dr. Boon moved that the Board approve the Bid Report for December 2003. The motion was seconded by Mr. Trujillo and unanimously approved as presented in public hearing.

In response to a question from Dr. Boon asking for an example of how the college district utilizes these contract vendors, President Israel said that purchases are made for such items as small maintenance supplies, oil for machinery or hand tools. The college district has very limited storage so some supplies are purchased as needed. Audits are completed on these accounts and the number of employees allowed to purchase is limited. If the total of all purchases against the contract purchase order exceeds \$25,000, additions to the amount must be board approved. Mr. Hall said that the theatre staff also purchases equipment and supplies to build sets through these contract vendors. Mr. Justice asked about the possibility of obtaining reports to show how the estimates on these purchases compare to actual expenditures.

INFORMATION REPORTS

- 1. Budget Status Report as of 02/29/04. Mr. Hall reported that 96.5% of tax revenue has been received. He stated that the college district would be collecting taxes in arrears. Expenditures exceeded revenues for the month of February; however, we are on target for this time of year. President Israel said that newspapers are reporting that foreclosures on commercial property in Collin County are at a higher rate than in the 1980s and commercial foreclosures can be a hard hit on the district's revenues. President Israel and Mr. Hall will meet in a month to review foreclosure activity as it affects the college district.
- 2. Investment Schedule as of 02/29/04. Mr. Hall reported that Texpool is currently paying 1.0281% and Texstar is paying 1.0363%. In order to get a good rate of 4.6%, investments would have to be tied up for 30 years.
- 3. Quarterly Investment Schedule ending 02/29/04. The Quarterly Investment Schedule was presented by Mr. Hall showing all investment activities taking place for the quarter ending 02/29/04. This report shows that the college district's investments are in compliance.
- 4. Summary of Foundation Payments to the District 02/29/04. Mr. Hall reported that funds in the amount of \$3,533 were received from the Foundation for the month of February 2004. Year-to-date receipts total \$70,583.

PUBLIC COMMENTS

None.

PRESIDENT'S REPORT

- 1. President Israel reported that Monopoly on Ice raised a gross total of \$190,000. He thanked Mac and Sherry Hendricks for their generous contribution. One-half million dollars have been raised with the Monopoly fundraisers through the efforts of the trustees, administrators, faculty, staff, students, and community support.
- 2. Kris Berg, Director of Jazz Studies for the college district, has been named Director of the 2004 International Association of Jazz Education's New York Community College All Star Big Band. Kris and several of the college's jazz students provided entertainment during Monopoly on Ice.
- 3. The Economic Summit will be held on Tuesday, March 30 at the Spring Creek Campus. Three hundred participants have registered to attend.

4. President Israel will participant in an in-service orientation for five new members of the Foundation board on Wednesday, March 24 at Courtyard Center. Robert Keahey will also attend.

ANNOUNCEMENTS AND ADJOURNMENT

Mrs. Bauge thanked Paula Roman, the staff of the Foundation, and everyone who participated in Monopoly on Ice. She said it was a fantastic fundraiser and she is excited about plans for a new scholarship fundraising program next year. Chairman Roach echoed Mrs. Bauge's comments and thanked her for her tireless efforts on behalf of students.

On motion of Mr. Justice, seconded by Dr. Collins, Chairman Roach adjourned the meeting at 8:50 p.m.
