Feedback was taken from the November 17<sup>th</sup> AGS Council meeting regarding FMA (Local) and incorporated into the edits that are being recommended and brought forth for the first reading. First reading will go to OEP (Organization, Education, and Policy Committee) in December. If the Board approves the first reading, there will be an opportunity to review again before the second reading goes to the Board in January.

#### **Discussion Items:**

- Defining Shared Governance Cabinet; Roger Ward
  - 4 documents distributed for reference prior to November meeting
    - AAUP Shared Governance, AAUP on AGB Statement on Governance, AGB Board of Directors' Statement on Shared Governance, How to Make Shared Governance Work: Some Best Practices

Began discussion regarding shared governance and the basis for developing a definition. Referenced the documents that had been provided prior to the November 17<sup>th</sup> meeting. General understanding and agreement by AGS that there is not a universally accepted definition for shared governance. Brainstormed ideas, key considerations, and terms as framework for building a definition. Some of the comments and ideas shared:

- Successful policy of shared governance is going to take the ongoing education of all stakeholders
- Collaboration together will bring in the best interests of all parties involved, especially the students
- Can be a decision-making model; joint effort that is taking place among various components
- Relevant voices are heard
- Integrated leadership
- Will help people from different groups feel they have a voice; ideas and concerns are taken seriously
- Work in progress, requires communication and understanding

Shared from Statement on Government of Colleges and Universities:

Although the variety of such approaches may be wide, at least two general conclusions regarding joint effort seem clearly warranted: (1) important areas of action involve at one time or another the initiating capacity and decision-making participation of all the institutional components, and (2) differences in the weight of each voice, from one point to the next, should be determined by reference to the responsibility of each component for the particular matter at hand, as developed hereinafter (Joint Statement by the AAUP, ACE, AGB, saved as 'AAUP Shared Governance' in November 17, 2021 agenda folder).

**Action**: Send ideas on shared governance definition to Dr. Schumann. Suggestions will be shared with Dr. Wendy Commons and Kim Davison, who are working on the initial draft of a proposed definition for review.
