Lock Down Browser in Classrooms	H. Webb-Losh	Heather reported that quite a few faculty are encouraging students to download Respondus Lock Down Browser at home. She has talked with David about whether is a good idea to put it in some of the classrooms so faculty can monitor testing. Mervat said it may be a good idea, but questioned whether it would be needed if the teacher is in the classroom. Heather said it is enabled in Canvas, but the actual browser is currently in the Testing Center and this would give another option for faculty. David said the college is licensed for Respondus so it can be used in any location. Dustin asked if it can only be used on college computers or on the student's device and what the process would be to download on their computers. Heather said it may give a false sense of security in that just because it is downloaded does not prevent a cheating scenario. Dustin and Heather will discuss further regarding utilizing in the classroom. Mark will research whether there is an option for use with mobile devices. Ann and Heather can work on information for use by the HelpDesk to support, and Heather will provide the link because it is different for each school. David will work with Mervat and the faculty committee to get the word out and to provide best practices for faculty.
