Syllabi are customizable. Need some guidance. Heather will met with their IT, has set up a time to meet after Thanksgiving. Just want to make sure how it connects to Banner, which single sign-on solutions they support. Did not receive any other vendor replies. Might be sole source. Concourse has been around since 2007, started by students. Fairly small but robust company. Mervat reached out to Dr. Hardesty about the determination of the standardized sections of the syllabus. Concourse mentioned they are working on book ordering. Might be able to send to B&N. Associate Deans would like the book ordering process to be streamlined and this might help. Several have had issues with getting the correct books at B&N. B&N is currently working on First Day Access to Coursework pilot program.

Student Starting Line in Canvas Update	D. Hoyt/ A. Blackman	Third iteration of Starting Line – Michelle Millen – working with student enrollment services. It is moving along, possibly up and running within a month. Student app should be up and running also with access to some of the same information. People might look for information in different locations. Students might have a hard time finding Starting Line Courses in Canvas. Might be confusing. Working to make it easy to navigate. Dr. Huppe did a trial run. Its purpose is to organize existing content, not create new content. It is searchable. Concern that it might just be more white noise for the students. Need to be cautious in creating too much of a good thing. Canvas is being focused on the classes the students are currently enrolled in. Worth more conversation.

ADA Compliance for videos	A. Blackman	ELc is looking for new ways to do things. Soft Chalk beta test has been successful, but has been found to not be an option. Looking at ArcMedia and TechSmith Relay. Might be beta testing both of these.  Just using YouTube and their captioning, Does not make it ADA compliant. Just have video with the audio and have a script link. TechSmith Relay and ArcMedia offer all those options. Must be ADA compliant from the get-go, not after a student complains. Many of the courses are problematic, especially math courses. We are trying to get the best out there, but there is a lack of good programs to make it happen. Need to be documenting our best efforts.
