- I. Introductions Dr. Bill King
- II. Door Numbering for Emergency Response Mike Messina Implemented to aid emergency responders in quickly locating current location and providing quick response. No longer using alpha numeric codes on campuses except for the Technical campus. Working with the Allen fire marshal to develop a system for the Technical campus due to multilevel elevations.
- III. Safety & Security Audit Overview/Update (JCAR) Mike Messina Assessment is completed every 3 years per Texas state law. It is an 800+ question audit that was boiled down to approximately 40 questions that apply to our college. It allows us to make sure we stay in line with state standards and continue process improvement with 632 areas of criteria across the district that must be met. We are in good shape per this current audit. The goal is to exceed expectations.
- IV. Safety & Security Projects Bill King The Board of Trustees has never voted no to any safety and security item since Dr. King joined the college. Dr. King presented PPT from executive session.
  - Will CBORD be installed on all doors in the district? No, too costly. The faculty see it as beneficial for adjuncts that don't have keys. Suggestions were made by other provosts regarding key lock/box/pad systems to alleviate this.
- V. School Marshal Update Chief Scott Jenkins
  All marshals are outfitted with bullet proof vest rated for rifle rounds and a college branded sash/vest to help identify them in a crisis. The average cohort size is 8 from Collin, and the average class including other students is 15. Marquee signs are in the approval process and will be installed on all campuses. Training participants from Princeton ISD, Prosper ISD, Texarkana ISD, and Bob Hope private school have all participated in the recent classes.

Motorola/Avigilon – The camera system was fully installed as of this week. It was recently successful in catching a person of interest who was abusing computer lab access and use and

was charged (criminal trespass). The next task is to optimize the system (i.e. A behavior on one campus is not unusual on another. Teaching the system to differentiate). License plate readers will come online in the near future. Delayed due to licensing issues.

- VI. ALERRT & AAIR Training Chief Scott Jenkins
  These are 16-hour training programs mandated by the state for all officers every 2 years, our
  officers go through every year.
- VII. Criminal Incident Updates Chief Scott Jenkins
  It has been a very safe summer and semester. This is a low in the number of police involved encounters in the 7 years Chief has been at Collin.

There was a second hoax event on Plano campus. It came in on the non-emergency line. It was ruled a hoax and cleared in 2 hours without disruption to students and classes.
