 - No, not every course will be included in the PLOs. Hypothetically, the program could create a new PLO for it, but it's not required.
 - Does it matter if the title for BNKG 1343 is “Law and Banking” or “Banking Law”?
 - Yes, the title of the course will need to match what's in WECM.

 - There are asterisks on courses to note that they're part of the designated Field of Study on both the associate degree and the certificate. Do we need to have the asterisks included on the certificate if this award already requires only the designated Field of Study courses?
 - No, we can remove them.
 - For the associate degree, should we clarify in the footnotes that the elective requirement must equal three credit hours?
 - Psychology doesn't have a course that's not three credit hours. Also, the open

- elective isn't restricted to a three-hour course, so the student could register for a four-credit hour elective and have three of those credit hours applied to their degree.
- Students will need to check their degree audit to make sure they've taken enough credit hours to satisfy the elective requirement, as taking a one-credit hour course will not meet the award requirements for graduation. They would need to register for additional courses until the remaining elective credit hour requirement is met.
- ◆ For the *Directed Electives* that we do not offer, would that negatively affect the student when they transfer?
 - Yes, although, Collin College already offers most of the ACGM courses that can be applied towards the various *Directed Electives* requirement.
 - Also, we don't want to list every elective, because there may be some WECM courses mixed in with the ACGM courses and WECM courses generally do not transfer.

Guest speaker, VP P-12 Partnerships and Districtwide Scheduling, Craig Leverette

- Dual Credit
 - There has been improved communication since moving it all under one umbrella.
 - Goals for the future of dual credit with Collin College – streamlined and quick communication between college and ISDs, better relationships with P-12 partners, better support for students in each specific type of P-12 Partnership program, eliminate ISD staffing requests through standardized language sent to ISD as part of the partnership agreements, provide better orientation to the dual credit program for prospective dual credit students and parents
- Scheduling
 - HB 8 influencing scheduling significantly
 - Extra money attached to dual credit transfers
 - Goal – minimize roadblocks to completions
 - New software to streamline building the schedule – data-driven
- Needs Faculty Council Help
 - Wants dual credit grades weighted the same as AP/IB course options in all ISDs – roadblocks to this include faculty letting students out of class early, inconsistency between faculty on student outcomes (F/W vs all As)

Vice President's Report

- Inviting ideas for how to handle the Sunshine Fund money

President's Report

- 50 spots at TCCTA (Texas Community College Teachers Association) for adjuncts are being paid for by the Dean's budget money
- Adjuncts have up to a week of sick pay but no professional development pay (seeking a recommendation for professional development pay)
- Faculty Handbook should not be updated during the academic year per Abe Johnson; updates since the beginning of this academic year are in this upcoming Faculty Newsletter
- Faculty Absence SOP (Standard Operating Procedure) – Faculty Council recommends a SOP statement for planned versus unplanned absences (it was emailed out before the meeting)

Dean of Students Task Force Report

- Scholastic Dishonesty Proposal - passed for recommendation

- Faculty will be allowed to put a placeholder of “0” for assignments with suspected plagiarism until DOS (Dean of Students) makes a determination. This grade may not be used in final grade submissions.
- Requires syllabus statement changes and board policy changes

Student Evaluations Task Force Report

- Revised survey should have no more than 8-10 questions (fewer is better)
- Each question should have a text entry box for comments to explain
- Target date is Fall 2025
- Reaching out for feedback on the constructs on which faculty want to be evaluated

Procedures and Nominations Committee Proposal - passed

- FT Nominations and Elections are done by division, not campus
 - 1-25 (1), 26-49 (2), 50+ (3) representation to faculty on the side of inclusion = about 5% representation
 - 23 to 29 representatives – largely from the workforce programs
- Adjunct Nominations and Elections
 - Maintain four adjunct faculty as currently distributed with the addition of two workforce specific representatives

Resources and Renumeration Committee Report

- Overloads Statement
 - Proposal passed for overloads statement that allows for overloads without pressure placed on faculty to take overloads
- Discussion on Class Caps and Large-Group-Instruction statements was tabled until the April meeting
