Prior Learning Assessments

- Prior Learning Assessment for Health Professions – Certified Nursing Aide
 - Three tracks within the PLA
 - Credit for NURA 1301 and NURA 1160 would be given to students that have already passed the NATCEP for CNA including skills demonstrations
 - The CNA OSA will allow someone with CNA skills to pursue AAS and other tracks, such as EKG, PCT, PHLEB, etc.
 - Dr. Leverette motioned to approve. Dr. Mesch seconded. Unanimous approval.

- Prior Learning Assessment for HVAC
 - Targeted toward students with 3-5 years field experience
 - Credit is dependent on detailed job descriptions/experience, written assessment, and skills demonstration. Must also show proof of EPA 608 and 410A certifications.
 - Students with 3 years experience receive credit for first 3 courses, students with 5 years experience receive credit for all six courses
 - Dr. Corwin motioned to approve contingent on request to department to clarify course assessment grading and added statement that assessments will be monitored and reviewed. Dr. Lee seconded. Unanimous approval.
