Kathryn Fant called the meeting to order at 1:30 pm.

New Curricular Proposals

- ♦ Communication Design Richard LeBlanc
 - Program Revisions
 - O Associate of Applied Science Communication Design
 - * This degree was separated into two tracks for each specialization. Course sequences were changed as needed for each track.
 - o Graphic Design Track (new)
 - User Experience Design Track
 - PSYC 2301 is recommended as the Social/Behavioral Sciences course, but not required.
 - MATH 1342 is recommended as the *Mathematics/Natural Sciences* course, but not required.
 - SPCH 1321 is recommended as the Speech course, but not required.
 - * CAB Discussion
 - What is User Experience Design?
 - This is about designing user experiences centered on things like mobile apps to design more effective digital products. This program will focus on the design end rather than the programming end. Graduates in the industry would work not only with designing apps, but

with conducting research with the team to learn more about the user and their needs. It's more of a humancentric way of designing.

- In comparison, Graphic Design is more traditional and will focus on print design, branding, and advertising. Graduates in the industry would work on magazines, logos, brochures, print ads, outdoor boards, etc.
- o If a student is not able to take ARTV 1371 in the *Third* (i.e. Summer) *Semester*, will the student still be on track [to graduate on time]?
 - The student will need to take 15 credit hours in the SECOND YEAR First Semester to stay on track. This will be an option, because ARTV 1371 can be taken along with the courses in that semester. However, ARTV 1371 must be taken before SECOND YEAR Second Semester, because FLMC 1331 has ARTV 1371 as a prerequisite.
- Are you recommending MATH 1342 for *Third Semester* because it's beneficial to the last semester?
 - Yes.
- Would it be better to move MATH 1342 to a longer semester and move PSYC 2301 to the summer?
 - It's preferred to keep it as it is, because PSYC 2301 compliments UXUI 1370 without duplicating content and we don't want to lose the parallel between these two classes.
 - Students who have concerns about taking an accelerated math course have the option to take a 10-week summer option instead of a 5-week summer option.
- Can students pursue both the Graphic Design and User Experience Design tracks?
 - No, students will only have the option to choose one track. The goal is to eventually have two stand-alone degree programs, but due to the limited number of fulltime faculty, an AAS with two track options is the best approach at this time.
- Certificate Level 1 Graphic Design Foundations
 - * Changed title from Communication Design.
- Certificate Level 1 User Experience Design Foundations
 - * Removed ARTC 2335, ARTV 1371, and UXUI 1371.
 - * Added ARTC 1302 (Digital Imaging I).
 - * Decreased the total number of credit hours from 24 to 18.
- o <u>Certificate Level 2 Graphic Design</u>
 - * Changed title from Communication Design.
 - * Changed the certificate level from "1" to "2".
 - * Decreased the total number of credit hours from 42 to 39.
 - * Removed the User Experience course options ARTC 1350, UXUI 1370, and UXUI 1371.

- o Certificate Level 3 Enhanced Skills Certificate Motion Graphics
 - * Footnote removed. Students will no longer be required to complete an AAS before pursuing this program. Students can take courses from the AAS and the ESC programs concurrently.
 - * CAB Discussion
 - So students no longer need to have a degree to earn the ESC?
 - Correct. This statement was removed to be compliant with the state requirement. However, classes within the ESC may require prerequisites that are found in the Communication Design programs.
- New Awards
 - o Certificate Level 2 User Experience Design
 - * CAB Discussion
 - Would you consider allowing other core options to be permitted for SPCH 1321 and MATH 1342?
 - No, not at this time. These courses are included as technical training, not as courses to complete core components. If a student were permitted to substitute other core classes for SPCH 1321 and MATH 1342 in the certificate program, the student would be missing specific skills training needed for workforce preparation.

- **♦** Photography Elizabeth Mellott
 - Program Revisions
 - o Associate of Applied Science Commercial Photography
 - * Changed courses sequences per advisory board recommendations.
 - * Changed PHTC 1311 from optional to required.
 - * This program will no longer specify if an elective is "creative" or "technical". Elective options will be referred to only as "TECHNICAL COURSE" on the program outline.
 - Certificate Level 1 Studio Production
 - * Increased credit hours from 15 to 18.
 - * Removed ARTS 1313, ARTS 2348, PHTC 2371, and CREATIVE COURSE.
 - * Added PHTC 1311, ARTS 2356, PHTC 1300, and two Technical Courses.
 - * This program will no longer specify if an elective is "creative" or "technical". Elective options will be referred to only as "TECHNICAL

COURSE" on the program outline.

- * CAB Discussion
 - o Are PHTC 1311 and ARTS 2356 equivalent?
 - No, the content of each class is different as are the Student Learning Outcomes.
- Certificate Level 2 Commercial Photography
 - * Removed PHTC 1300.
 - * Added PHTC 2371.
 - * This program will no longer specify if an elective is "creative" or "technical". Elective options will be referred to only as "TECHNICAL COURSE" on the program outline.
 - * CAB Discussion
 - o Is there a SECOND YEAR First Semester?
 - Yes, this is a typo. The SECOND YEAR Second Semester will be changed to SECOND YEAR First Semester.
 - Is there a reason why the Technical Course options are different for each category?
 - Originally, classes were separated into Creative and Technical options, but all courses have both creative and technical aspects. The two technical categories are separated with one course being more foundational and the other more advanced.

 - * CAB Discussion
 - o Is it an issue that the course requires two prerequisites?
 - No, PHTC 2308 is a more advanced course, so the content of both PHTC 1300 and PHTC 1353 is needed first.

 - * CAB Discussion
 - Are any of the course changes in conflict with WECM?
 - No, changes were either made to bring courses more in line with WECM or changes were made to information Collin added that were *in addition* to what's already in WECM.
 - For classes that have changed from a prerequisite of ARTS 2348 to PHTC 1311, what will be the process for students who already

completed the original prerequisite?

- Students will have the option to do a prerequisite waiver with the department.
- ♦ Motion to approve with correction in Certificate Level 2 (change SECOND YEAR Second Semester heading to SECOND YEAR First Semester heading) → seconded → passed

♦ Real Estate Management – Andrea Szlachtowski

- Program Revisions
 - o Associate of Applied Science Real Estate Management
 - * Moved MRKG 1301 to fall semester to better align with class availability. ECON 1301 was moved to the spring semester to keep the number of credit hours per term balanced.
 - * Removed GOVT 2305 and HIST 1301 from the program.
 - o Added Social/Behavioral Sciences course requirement.
 - * Added Real Estate Elective.
 - * Added Core options for *Mathematics*. MATH 1332 is recommended, but not required.

♦ Web & Mobile Development – Justin Lewis

- Program Revisions
 - o Associate of Applied Science Web Development
 - * Revised to focus more on programming than design.
 - * Changed title from Web and Mobile Development.
 - * Removed COSC 1315 and ITSE 2353.
 - * Added COSC 1436, COSC 1437, COSC 2436, ITSE 1346, ITSE 2371, and an ELECTIVE.
 - * Changed substitution for ITSE 2374 (Capstone) to ITSE 2380.
 - * Removed recommended math courses to allow for any *Mathematics* core options.
 - * Recommended PHIL 2303 for the *Humanities/Fine Arts* course.
 - * Changed sequencing of courses as needed.
 - * CAB Discussion
 - O In the program, math is written as "Mathematics options (See Natural Sciences / Mathematics)". Does that mean a student can take a science course instead of a math course?
 - No, this should be rewritten as "Mathematics course".
 - CAB Recommendation: Swap ENGL 1301 and the *Social / Behavioral Sciences* in the program. Foundational skills learned in ENGL 1301 can be utilized in other classes, so having ENGL 1301 earlier in the program can be beneficial to the student.
 - There's no proposer preference on which course is taken first, so moving ENGL 1301 earlier in the program is an option.
 - Besides, SQL, what other programming/scripting languages will students learn in this program?
 - Students will learn C++, Java, JavaScript, HTML, and CSS.
 - Python, PHT, and C# are available as electives.
 - o For the electives, can students choose from any of the areas

(Front-end, Back-end, etc.) or are they required to choose a certain number from a certain area?

- Students are not required to take a certain number of hours from a certain area. The two electives can be any of the options listed at the bottom. The student can choose whichever elective classes best support their academic/career focus.
