- Curriculum Office: Additionally, only Irene Bowen is listed as the proposer on pg. 1 of the proposal. In the post-CAB document, Bridgette Kirkpatrick’s name will also be added.
- CAB member: Did you say BITC 1250 is the shortened version of BITC 1350?
 - Proposer: Yes.
- CAB member: Did you take out some topics? How different is it?
 - Proposer: We will remove or (more than likely) shorten topics. In the past and for future sections, BITC 1250 will be taught as a case studies course in which the instructor will pick the most relevant case studies and then ask the advisory board which one they would most like us to cover. Actually, one topic we’re adding is Cybersecurity, because it’s something our advisory board would like us to cover not just in the hospital setting, but also in the industry and research setting.

 - CAB member: If even one student who has declared Metal Arts wants to continue pursuing the program, what happens?
 - Curriculum Office: When a program is closed, the state officially gives the college three years to teach it out. In some cases, the program can be terminated quickly, but if there are still students in the program, a teach-out plan will need to be implemented to help those students successfully complete their intended awards. If a student chooses to continue, the instructor may need to teach classes at the Technical campus or find appropriate course substitutes to help them finish the program. The department may also overlay courses, meaning that students from similar courses may be taught in the same class together. For example, the proposal mentions that some of the Metal Arts courses were overlaid with Sculpture and Design II.

- Curriculum Office: Can you explain the impact Medicare had on the decision to offer the program?

- Proposer: Primarily in long-term care facilities where people go and reside in a place that becomes their home, Medicare mandates that these individuals living in facilities have opportunities to flourish and live full lives. So, there are activity professionals in these facilities because of this mandate, but they are not required to hold any type of activity care certification to be in that position. It would be nice if they did require some type of certification. I definitely see the need to have individuals staffing these positions who have more formal education. There *are* people there doing the job, but it could be so much better.

- ◆ **CAB Discussion:**
 - **CAB member:** What do the “IF and “IS” represent on the Stacked Credentials?
 - **Proposer:** Those are the two Computer Networking tracks: Infrastructure (IF) and Integrated Systems (IS).
 - ◆ **CAB member:** CCNA courses are all eight weeks. However, CCNA 2 is a prerequisite for CCNA 3. Is there going to be a problem if they’re in the same semester?
 - **Curriculum Office:** No, they’ll be able to take CCNA 2 in the first eight weeks and CCNA 3 in the second eight weeks.
 - ◆ **CAB member:** Can they register for CCNA 3 at the same time as CCNA 2 even if the student doesn’t meet the prerequisite requirement yet?
 - **Curriculum Office:** I believe the department has it set up where they can check to see if the student passed CCNA 2 at the end of the first eight weeks. If not, then they’re not eligible to move on to CCNA 3.
 - **Ex officio:** Banner won’t allow students to register for both courses in back-to-back eight-week sessions without a prerequisite override. However, with Workday, students will be able to register for CCNA 2 and CCNA 3 at the very beginning of the semester.

Deans' Liaison Report – Lupita Tinnen
January 18, 2024

- ◆ Allison Venuto was a guest. She came to gather feedback about training and development topics that faculty and staff could benefit from. She can also meet with the deans individually. She is meeting with various groups to get information.
- ◆ Some ideas that were mentioned:
 - Diving into our data sources and where to find certain things for staff and workforce faculty.
 - Next level supervisor training above Leading for Excellence.
 - Customer Service training.
- ◆ Dr. Hardesty visited to ask for a volunteer to lead the General Education Steering Committee and their program review. Meredith Wang volunteered. This will be a 3-4 year commitment.
- ◆ Nate Walker gave a short presentation about the Writing Center tutor compensation and salary review. There had been concerns about recruiting and retaining tutors. They revised job descriptions and were included in the market study they do every few years. FT tutor and Lead Tutor. Job descriptions were analyzed by an outside consultant.
- ◆ QEP (Quality Enhancement Program) Update by Bill Horstman:
 - James Wicks is the lead for QEP. It can be found under My Workplace in CougarWeb. They are in the process of writing a draft and hope to have it completed by the end of the semester or summer. One thing on it is making the Learning Frameworks course more applicable to students falling under the Developmental Education (DE) level (i.e. students who are not TSI ready). James is having meetings with Learning Framework faculty. They are working on adapting the curriculum, which will be faculty-led. A question they are asking is to what degree do the Learning Frameworks SLOs need to change to make it better for the students who really need the course. This would not happen until the QEP implementation phase (2025-2030). They hope to roll out the revamped EDUC 1300 by Fall 2026 requiring it for a segment of DE students. By spring 2030, the hope is to require it for all students placing into a DE level.
- ◆ Senate Bill 8 Committee has an upcoming meeting. Currently auditing programs to see where we are at with completers. Discussion of general education classes in workforce programs and their effect on completers.
- ◆ Multi-Year Contract (MYC) Taskforce update. The committee sent their recommendations to Dr. Johnson for his review. Provosts were given an update but we are all waiting to hear about next steps.

- ◆ Provosts update: New guidance on Faculty Load assignments is up in CougarWeb. They will be reviewed regularly.
- ◆ Discussion about having deans send provost reports with faculty teaching above 24 WLU.
- ◆ New faculty requests, Dr. Johnson is meeting with Dr. Matkin and we can figure out where we are going.
- ◆ Committee being formed to draft a statement to be sent to faculty when an administrator enters their Canvas course.
- ◆ Standard Schedule Grid. Wendy was looking through for Workday purposes for standard courses. Historical data needed to be added into Workday. She will send us a copy of what she found. It's important to follow standard start times.
- ◆ Multiple Academic Appointments with discipline clusters is still a work in progress. If they can be credentialed for one, they can be credentialed for others. She will send an email invite. They will investigate whether there are overlapped disciplines. It was recommended to add some associate deans or directors to the committee.
- ◆ Staffing practices. From the last AD/D meeting. Have a talk with your direct reports on how they are approaching staffing. There is a need to encourage hiring even for 1 class.

- ◆ Kimberly Harris has started sabbatical, so Rebecca Orr is President of Faculty Council for this semester.
- ◆ President's Report
 - Discussed who should act as faculty peer on Appeal Review Board for grievances; suggested Faculty Council Executive Board.
 - Email FC@collin.edu for any incidents where policy is not being followed by administrators, especially in the areas of class assignment scheduling and search committee formation/administration (policies went out in last newsletter).
- ◆ Task Forces
 - Gradebook presented survey results with about even split on question of whether Canvas gradebook should be mandatory. Without clearer parameters of what the administration is proposing, the task force has only vague suggestions about what might be needed for a higher gradebook participation from faculty.

- Dual Credit also presented some of the survey results which were much more positive than originally expected. They identified some possible problem areas that could make dual credit more appealing to faculty should those areas be addressed.
- Student Evaluation worked up four criteria for any evaluative questions for those end-of-course evaluations including:
 - Questions must be something that students are equipped to answer
 - Questions should be void of biases
 - Questions should be applicable to any type/modality of course
 - Questions should be in language that all students can understand
