• PLA Review Board Discussion:

- For the Certificate Level 1 Foundations of Hotel Operations, what are you doing to prevent students from exceeding the 75% PLA maximum?
 - * We have forms that are used for tracking. Also, the student would be told if they plan to pursue just the certificate, they would not be eligible to receive PLA credit for [HAMG 1313], which would bring the percentage down to 66.67%. Currently, only six students have declared this award and all of them are entry-level students, most right out of high school, so they won't have a certification like CMM. It shouldn't ever be an issue, but between [the career coach] and myself, we will be making sure students can petition to graduate for that certificate using eligible PLA [without exceeding the 75% maximum].
- Discussion Summary (Minutes: 17:40 29:46)
 - * Departmental exams can be administered by either the Testing Center or the academic department. In either case, a fee of \$30.00 will be charged

to each student for each departmental exam. The student will need to provide a receipt of payment from the Bursar's Office to the department or the Testing Center (depending on where the test is administered) before they can sit for the exam. The **PLA Review Board recommendation** is to add a note to the Evaluation Components and Criteria form for TRVM 2301 to confirm this is a required cost for students.

• PLA Review Board Discussion:

- Will exams be administered on demand or is there a schedule for them?
 - * Exams would be on demand. They would be administered one at a time in the sequential order as designated by the department. Two could potentially be taken in the same day, but that isn't recommended.
- \circ $\,$ To confirm, do all programs fall below the 75% PLA maximum threshold?
 - Yes. The only program that reaches the threshold is the Certificate Level 1 – Entry Welding Certification and out of those four required courses, students are only allowed to test out of three.
- If they fail an exam, are they eligible to retake it? If so, how long do they have to take to retake it?
 - * With PLA, students only have one attempt at earning a specific PLA opportunity, so they are not eligible to retake one of our departmental exams if they fail it. For example, let's say a student successfully earns for two courses, but fails the exam for the third course. They would still earn credit for the first two courses, but not for the third; they would then need to take that third class in the program. Also, they would not be able to reenter the PLA process for a period of 24 months.
- If they aren't eligible to retake it, do they start classes where they stopped PLA? Are the exams administered sequentially?
 - * Yes, they will begin taking classes at the point where they did not successfully complete the departmental exam. Also, the exams are administered sequentially, which is why if a student fails one of the

exams, it ends the PLA testing for that particular student.

- How many professors are part of the testing process? If there are multiple professors, how do you make sure the grading is consistent?
 - * Only one professor will be administering the exams. The written exams are very straight-forward for grading. For the practicals (i.e. the skills demonstrations), those would be based on industry standards. We have different welding codes that are in place for different processes and applications such as structural welding and pipe welding. We use those codes to determine if a student has successfully demonstrated the desired skill. For our advanced courses, we also do non-destructive testing, so we would take their weld samples and destructive test them to see if they meet the codes set by industry standards.
- **PLA Review Board Recommendation**: Just like the previous proposal, the \$30.00 testing fee should be added.
