Review April 18, 2022 meeting with Dr. Johnson and Dr. Lee.

- 30% Southern Association of Colleges and Schools Commission on Colleges (SACSCOC)
 deficiencies are distant education related. Every deficiency found will need an action plan. Dr.
 Johnson requested to be proactive in planning and preparation.
- Blended/Hybrid courses will need an OAB/online evaluation method, Pam suggested leaving this
 between the eLC and instructor designing the course. It sounds like we could use the checklist,
 but some parts of the OAB rubric may need to be modified. This could be an internal process
 within the eLC. All online, blended, hybrid courses need to meet a minimal standard since part
 of the course is offered online.
- Clear institutional expectations for each type of online course-type.
- Clear expectation for continuous improvement, ie every 2-3 years for fully online, and what for others (blended or hybrid).
- Prescriptive standards for any use of an online format ie Canvas shell framework, student intro to Canvas, eLC already has this in place.
- Continued professional development for online faculty such as continuing education offerings, or prescribed classes (Growing with Canvas-new eLC course in development). How often?
- Adjunct teaching online courses, did not have favorable student evaluations/experiences? Do
 we need a plan for this, who can teach online, example, at other schools the faculty member
 must have instruction 3 semesters in-person teaching the course before teaching online?? All
 online faculty must already complete one QM workshop and Teaching with Canvas online.
- Consider costs for technology upgrades in relation to number of students taking online format courses. This could be universal among the 3.
- Consider how to sustain online learning environments, quality education with CI, OAB process, eLC internal process.

Tentative SACSCOC visit is 2023.
