Acronyms/Terminology	Description
Α	
AA	Associate of Arts degree.
AAA	Associate of Applied Arts degree.
AAS	Associate of Applied Science degree.
AAT	Associate of Arts in Teaching. Board-approved collegiate degree programs consisting of lower-division courses intended for transfer to baccalaureate programs that lead to initial Texas teacher certification.
Academic Courses	Credit courses taught for the purpose of contributing toward the requirements of a baccalaureate degree and are transferrable to a university. Academic courses contrast with technical, remedial, and noncredit courses.
Academic Fresh Start	State law (i.e., Texas Education Code Section 51.931) allows applicants who are residents of Texas and have academic credits earned 10 or more years prior to the starting date of the semester in which they seek admission to Collin College to have those credits or grades not be considered in the admission decision. This allows students to begin a new course of study with a clear academic record. Note that this is an all-or-nothing option. Applicants are not able to pick and choose which courses to include or exclude. If the Academic Fresh Start option is selected, credits for any courses taken 10 or more years ago will not be counted. This means courses taken previously cannot be used to fulfill new prerequisite requirements, or towards the new degree, or in the new GPA calculations. Applicants must complete the admissions process. Applicants under the Academic Fresh Start provision must still meet the criteria for the Texas Success Initiative (TSI).
Academic Partnerships	A partnership between colleges/universities to collaboratively facilitate the delivery of bachelor's, master's, and doctoral degrees to service area residents. For details of Collin's partners see https://collin.oudeve.com/chec/
Academic Program	An instructional program leading towards an institutional credential, certificate, associate's, bachelor's or master's degree or professional degree or resulting in credits that can be applied towards those degrees.
Academic Year	The customary annual period of instruction at a college, university, etc., that typically begins in September. At Collin, the academic year runs from September 1 of a given year to August 31 of the following year. For example, September 1, 2023, to August 31, 2024, is Academic Year 2023-24.
Academically Disadvantaged	Students are identified based on the Texas Success Initiative (TSI) approved test; students who fail one or more sections of TSI reading, writing, or math. Note that being academically disadvantaged does not include students with learning disabilities.
ACCESS	Accommodations at Collin College for Equal Support Services (ACCESS) Office. Following the Americans with Disabilities Act of 1990, Collin provides services for students with documented disabilities. The services include interpreters, note-takers, scribes, readers, and testing accommodations etc.
Accountability System	Texas' Higher Education Accountability System provides data on the state's performance on critical measures as laid out in the Texas Higher Education Coordinating Board's strategic plan.

Acronyms/Terminology	Description
Accreditation	A process of demonstrating that an institution or instructional programs within an institution have an appropriate purpose, documented outcomes consistent with that purpose, resources adequate to accomplish that purpose, and demonstrate ongoing improvement. Colleges in Texas should refer to the Principles of Accreditation published by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). The CB recognizes other accrediting agencies for our Allied Health Programs which can be found on Collin's website at: https://www.collin.edu/aboutus/index.html.
ACGM	Academic Course Guide Manual. The Lower-Division Academic Course Guide Manual is the THECB's official list of approved general academic transfer courses that may be offered for funding by the community and technical colleges.
Al	Artificial Intelligence is the simulation of human intelligence by machines, especially computer systems. Al ingests large amounts of data, and based on analysis of the data and based on the patterns in the data, future predictions are made.
All College Day	A College-wide all-day activity held twice a year, in August and January, before the start of the long semester. The President talks about the important issues relating to College/Higher Education. Awards are given to outstanding faculty and staff, and new faculty and staff are recognized. Professional development activities may be provided in the afternoon.
ApplyTexas	A Texas-wide online application portal used to gain admission to Texas public institutions. Students applying to Collin College must submit a completed ApplyTexas application. This portal offers students the convenience of applying to multiple schools using a single application. This is like Common Application; a centralized application system used by over 900 colleges and universities across the US and internationally, which is not specific to Texas.
Argos	Argos is used by IRO to retrieve data from Banner. Argos by Evisions is an Enterprise reporting solution that gives quick access to data. It is a reporting tool that helps deliver insights needed to make timely, better-informed decisions. It allows users to run adhoc queries and dashboards. Argos users are of three types: Datablock designers, Report Writers, and Report Viewers. IRO users fall under the first two user categories.
Articulation Agreement	An agreement between postsecondary institutions or programs that facilitates the smooth transfer of credits from one institution to another.
AS	Associate of Science degree.
Assessment	A method to determine preparation for college-level coursework.
Asynchronous Course	Online course that allows a student to watch lectures and complete assignments in their own time rather than having to attend classes at specific time.
At-Risk Student	In general, students who have a higher than average probability of dropping out or failing school. The term came into use following the 1983 report of the Commission on Excellence.
Attempted Hours	The number of hours for which a student is enrolled at Collin in a given term. This includes all college-level courses as well as developmental courses.
Average Time to Degree	The average length of time in years to complete a degree. Students are tracked for total years and months that have elapsed from the first date of entry until program completion. High school dual credit and developmental education hours are excluded. Source: THECB CBM001, CBM009, CBM00N.
Award	A credential granted to a student for successful completion of a designated curriculum such as a degree or certificate.

Banner	Ellucian Banner is an ERP (Enterprise Resource Planning system) specifically designed for higher education. Collin College adopted Banner in fall 2008 and used it through summer 2024. It consists of six integrated systems: (1). Student, (2) Finance, (3) Financial Aid, (4) Human Resources, (5) Alumni Development, and (6) General that maintain student, financial, personnel, and alumni data. Banner stores data in about 4,000 Oracle tables. The Banner software acts as an interface to the ORACLE tables. IRO uses Argos to retrieve data from Banner.
Base Year (Base Period)	Runs from March 1 of a year through the end of the following February. Prior to the adoption of the HB 8 outcomes-based funding model in fall 2024, enrollment during in the Base Year determined enrollment funding for the following biennium.
BAT	Abbreviation for the Bachelor of Applied Technology degree.
Biennium	The two-year budget period used by the Texas state government. A biennium begins on September 1 of each odd-numbered year and ends on August 31 of the next odd-numbered year. Each biennium contains two fiscal years.
Board of Trustees	The nine (9)-member elected governing body of Collin College also referred to as the "Board."
BSN	Abbreviation for the Bachelor of Science in Nursing degree.
Building a Talent Strong Texas	The Texas Higher Education Coordinating Board's strategic plan for Texas higher education, approved in January 2022, focuses on three measurable data-driven goals the first two of which apply to community colleges. 1) Attainment of Postsecondary Credentials. Target: 60% of Texans ages 25-64 will receive a degree, certificate, or other postsecondary credential of value by 2030. 2) Postsecondary Credentials of Value. Targets: • 550,000 students will complete postsecondary credentials of value each year. • 95% of students will graduate with no or manageable undergraduate student debt in relation to their potential earnings (For more details, see: https://www.highered.texas.gov/our-work/talent-strong-texas/).

Calendar Year	Begins on January 1 of a given year and ends on December 31 of the same year.
Canvas	A Learning Management System used by Collin.
Capstone	Course-based learning experience resulting in a consolidation of student's educational experience and certifies mastery of entry-level workplace competencies. The capstone occurs during the last semester of students' educational programs.
Carl Perkins	Reference to a U.S Public Law more formally known as Carl D. Perkins Vocational and Technical Education Act stipulating that federal funds be awarded to post-secondary institutions to foster and promote workforce education.
Carnegie Classification	The Carnegie Classification is a taxonomy developed in 1970 by the Carnegie Commission on Higher Education for policy research. It classifies all degree-granting colleges and universities in the United States that are accredited by an agency and are recognized by the U.S. Secretary of Education into various categories based on their function and student and faculty characteristics. IPEDS uses the Carnegie classification to classify institutions. Periodically, the typology is revised as its universe changes. The latest changes were made in 2021.

Acronyms/Terminology	Description
CASMNS	The Center for Advanced Study in Mathematics and Natural Sciences. The Center offers advanced opportunities to students in the areas of biology, chemistry, physics, and mathematics. Students must have a GPA of 3.0 to be eligible.
CBM Reports	Coordinating Board Management Reports. All Texas Institutions of higher education must submit regular reports to the THECB to fulfill the provisions of the Higher Education Coordinating Act of 1965. The CBM reports are submitted to the Educational Data Center and are certified for accuracy by both the institution and the THECB.
CBM-002	An end-of-semester CBM report that provides Information about enrolled students' readiness for college-level instruction and remediation intended to help unprepared students be successful in freshman-level academic coursework as defined by the Texas Success Initiative (TSI) statute and affiliated rules.
CBM-008	The CBM-008 faculty report is an end-of-semester report. Its purpose is to report data on instructors who teach any classes reported on the CBM-0CS. It is reported each fall and spring.
CBM-009	The CBM-009 is an annual report on all degrees, certificates, core curriculum completions, and field of study awards during the prior fiscal year in active Coordinating Board-approved programs.
CB116	The CB 116 is a Supplemental Follow-up report of program completers by classification of Instructional Programs (CIP). The Texas Higher Education Coordinating Board (THECB) tracks community college program completers (graduates) in an effort to determine what proportion were "successful" in their subsequent endeavors. The successful completers are those who either are pursuing education at a post-secondary institution, have found gainful employment, earned a certificate of apprenticeship, or are enlisted in a military or peace corp. The THECB uses a multi-step tracking process to track graduates who have attended a Texas public community or technical college after they leave the colleges. The social security numbers of students are matched with the Texas Workforce Commission (TWC) and Employment Insurance (UI) records and the public higher education database maintained by the THECB. Whoever the THECB is unable to find via its multi-step process, it asks the institutions to track them.
CBM-00A	Noncredit student report submitted each quarter. The Continuing Education Student Report (CBM-00A) includes all students enrolled as of the official census date in continuing education courses (reported on the CBM-00C for state funding) where the official census date occurs within the reporting period.
CBM-00C	Noncredit course report submitted each quarter. All students enrolled in Coordinating Board-approved continuing education courses during a given quarter are reported on the CBM-00C. The courses reported on the CBM-00C include all specially approved continuing education courses (local need) and courses listed in the continuing education section of the Workforce Education Course Manual.
CBM-00M	The CBM-00M is an annual report on all Occupational Skill Awards (OSA) granted to students in active Coordinating Board-approved programs during the prior fiscal year. Beginning in fall 2024, the report will also include Institutional Credentials Leading to Certification/Licensure (ICLC).
CBM-00N	An irregular report submitted as necessary to notify the THECB of changes or corrections to student Social Security Numbers.

Acronyms/Terminology	Description
CBM-00S	This end-of-semester report (CBM-00S) reflects individual courses enrollments and grades, by student, as of the final day for each semester, and includes only Coordinating Board-approved courses for credit, whether the class is delivered on-campus or off-campus. Students who withdraw from a class on or before the official census date are not included in this report.
CBM-0C1	A student census report. The CBM-0C1 reflects data on all students enrolled at the reporting institution in courses (for which semester credit hours are awarded) as of the official census date. Students who withdraw from the institution prior to or on the official census date will not be reported.
CBM-0CS	The Census Student Schedule Report (CBM-0CS) reflects individual courses by student, as of the official census date. The official census dates are the twelfth-class day of the fall and spring semesters and the seventh class day of the summer session (10-week).
CBM-0E1	This student end of semester report reflects students enrolled at the reporting institution as of the final day of each semester. No record for the student is submitted if the student withdraws from the institution on or before the census date. If a student withdraws from a class after the census date, that class enrollment will be reported so that the CBM0E1 record matches the individual course records on the CBM-00S.
CCCCD	Collin County Community College District, or CCCC. The College rebranded itself as Collin College in 2007. The district headquarter is inside the Collin Higher Education Center in McKinney.
CDS	Common Data Set. It is a collaborative effort and initiative of major publishers like College Board, Peterson's, Wintergreen Orchard House, US & World News, and the educational community to have more accurate comparable data based on standard definitions. The objective of CDS is to improve the accuracy of data provided to students as well as to lessen the burden on the data providers.
CE	Continuing Education & Workforce Development Division of Collin College also known as Continuing Professional Development since 2024.
Celina Campus	Celina Campus opened in fall 2021. It is built on 75 acres and serves the northwestern sector of Collin County, including the cities of Celina and Prosper and the portions of Collin College's service areas in Celina ISD and Prosper ISD in Denton County. It is located at 2505 Kinship Parkway in Celina 75009. The campus is abbreviated as "CEC" in Banner.
Census Date	The census date is the official date when enrollment snapshots are captured for reporting to the THECB and official internal comparisons. For traditional 16-week courses during fall and spring semesters (10-week courses during summer), the census date is the 12th class day counting from the first class day and counting each day on which classes are normally held). It must occur on a day when the Registrar's Office is scheduled to be open so students can drop or withdraw from classes. For courses that run fewer than the traditional length, the census length is designated on page C1.1 in the THECB Reporting & Procedures Manual for Texas Community, Technical, and State Colleges.
Central Park Campus (CPC)	Central Park Campus (CPC) is the former name of the McKinney Campus. "CC" continues to be used in Banner as the abbreviation for McKinney Campus.

Acronyms/Terminology	Description
Certification	Certification can refer to at least two things. 1) Certification may refer to recognition by an agency other than a postsecondary institution that a student or former student has demonstrated through an examination process some degree of mastery of a designated body of knowledge or set of skills/abilities related to a specific occupation. Certification may result in higher pay or enhanced employment opportunities, but unlike licensure, it is not required for gainful employment in an occupational field. 2) Certification may alternatively refer to a process of validating and attesting to the accuracy of data submitted to the THECB for CBM compliance reports to the satisfaction of both the institution and the THECB staff.
CEU	Continuing Education Unit. CEUs are nationally recognized units used to record satisfactory completion of certain approved occupationally-related courses. One CEU is awarded for each 10 contact hours of instruction or activity. CEUs are awarded for successful completion of these courses.
CIP	CIP can refer to two things at Collin College. 1) The Classification of Instructional Programs (CIP); a taxonomy that uses six-digit numbers to label and classify instructional programs. It was developed and maintained by the U.S. Department of Education to facilitate reporting at the federal level and was subsequently adopted by Texas to facilitate state reporting. CIP 2000 is the latest update. Instructional programs can also be aggregated into four-digit and two-digit levels, covering a broader range of instructional programs. 2) CIP may also refer to Continuous Improvement Plans that are a component of Collin College's program and service review process. The CIP documents an instructional program's or a service unit's efforts to improve over time based on identified needs or weaknesses.
Clery Act	The Clery Act (The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, 20 U.S.C. § 1092(f) is a federal law that requires all colleges and universities that receive federal funding to disclose information about crimes that occur on and near their campuses. The Clery Act also requires colleges and universities to publish an Annual Security Report (ASR) informing their communities of campus safety policies and procedures, crime prevention efforts, and campus crime statistics. Colleges and universities that have on-campus student housing are also required to publish an Annual Fire Safety Report (AFSR) informing their communities of fire safety policies and procedures and fire statistics.
Closing the Gaps	Closing the Gaps (by 2015) was adopted by the Texas Higher Education Coordinating Board in 2000 with the goal to increase higher education participation and graduation by ethnic minorities and within science and health care programs. Basically, this State program was designed to close the educational gaps in Texas as well as between Texas and other States. Closing the Gaps focused on four components: participation, success, excellence, and research.
Co-Curricular	Programs and activities that directly complement classroom learning (e.g., field trips, guest speakers, etc.).
CoE	Council on Excellence is a group of elected full-time faculty members who serve as a peer-review body for the faculty contract renewal process. The committee also oversees the distribution of professional development and travel funds for full-time faculty, conducts the annual Outstanding Professor and Piper Professor selection processes, and oversees The University of Texas at Dallas (UTD) Scholarship Program. IRO conducts the annual elections of CoE members every spring and provides the election results to the chair of CoE.

Acronyms/Terminology	Description
Cohort	A cohort is defined as a group of persons sharing a particular statistical or demographic characteristic. For example, all students entering college for the first time in fall 2023 comprise the cohort of first-time-in-college (FTIC) students for that term. Cohorts can be used, for example, to track student retention over specific periods. The IPEDS GRS uses fall FTIC, full-time, degree-seeking cohorts to track the graduation rates. PEIMS uses cohorts to calculate dropout rates.
College Scorecard	Provides data and information on colleges and universities in the United States to help students and families make informed decisions about higher education. https://collegescorecard.ed.gov/
College-Wide ID (CWID)	Every student and employee at Collin College is issued a CWID. This unique number is used instead of a Social Security Number (SSN) or any other identifier when doing business with Collin College. CWID is used to generate accounts that facilitate access to Collin College's various online systems (e.g., Canvas, Collin Email, CougarWeb, etc.). In Workday, this number is called Student ID.
Collin College Mission Statement	Collin College is a student and community-centered institution committed to developing skills, strengthening character, and challenging intellect.
Collin College Vision Statement	Delivering a brighter future for our students and communities.
Collin Higher Education Center (CHEC)	The Collin Higher Education Center (CHEC) was created to house Collin College's administrative offices and, initially, through university partners, to provide Collin County residents access within the county to baccalaureate and graduate programs that Collin College does not offer. CHEC is located at 3452 Spur 399, McKinney, TX 75069 (the Northeast corner of Hwy 121 and 75 Central Expressway). In fall 2024, the instructional offerings from partner universities will be relocated to the Allen Technical Campus, and CHEC will be renovated to expand the space available for administrative offices.
Community and Technical Colleges (CTC)	A category of Texas public postsecondary institutions used by the Texas Higher Education Coordinating Board to group institutions whose primary missions are one- and two-year awards, transfer to four-year institutions workforce education, and college readiness training.
Community College or Junior College	In Texas, the two terms are used synonymously to refer to two-year postsecondary institutions that offer some combination of academic transfer curriculum, workforce education, and college preparatory instruction and that award certificates, associate degrees, and, in some instances, as is the case with Collin College, baccalaureate degrees.
COMPASS	Test of basic college-level skills developed by ACT and formerly used by Collin for Texas Success Initiative (TSI) compliance and placement. COMPASS scores are still found in Banner.
Competency-Based Education	An educational program designed to teach applied and/or job-related clusters of skills and knowledge that form the basis for evaluation of the student.
Completer	A student who receives a formal credit or noncredit award signifying successful program completion (i.e., degree, certificate, occupational skill award, institutional credential leading to certification/licensure (ICLC) from September 1 of a given year through the following August 31. Under the HB 8 funding model, completers are one of the primary drivers for performance funding.

Acronyms/Terminology	Description
Completer (IPEDS)	For IPEDS purposes, completers are students who received a degree or certificate from July 1 of a given year through the June 30 of the following year.
Completion Rate	This is an ambiguous term and may refer to a course completion rate or to a program completion rate, depending on the context. For the former, see Course Completion Rate, and for the latter, see Graduation Rate.
Completion Rate IPEDS	In line with provisions of the legislation, first-time, full-time, degree-seeking students who entered Collin College during the summer and fall of a federal reporting year are tracked over a three-year period (150% of normal time to degree completion) of their initial entry into Collin College. According to IPEDS, the Completion rate/Graduation rate, in line with the Students Right-to-Know regulation, considers completers as those students who received their degree/certificate (or completed a transfer preparatory program) within 150% of the normal time according to the institution's catalog. See Graduation Rate IPEDS.
Compliance Certification	A document submitted to the Southern Association of Colleges and Schools Commission on Colleges by member institutions documenting how they meet SACSCOC's core requirements and standards. The document is submitted 15 months prior to an institution's scheduled on-site reaffirmation visit.
Concurrent Admissions	Concurrent admissions refers to students who are enrolled at Collin and who participate in any of the concurrent admissions agreements that Collin has with partner universities.
Concurrent Enrollment	Concurrent enrollment can refer to one of two things: 1) students enrolled in Collin courses while still enrolled in high school and 2) students who are enrolled at Collin and other colleges or universities at the same time.
Contact Hour	A unit of measure representing one hour (50 minutes) of instructional contact between a student and a faculty member. In the past, community and technical colleges received contact hour reimbursement from the state based on the number of contact hours reported on designated CBM reports. After HB 8, enrollment-based funding was replaced by performance funding.
Cooperative Work Experience	Educational program designed to provide actual work experience related to classroom study and career choices.
Coordinating Board (CB)	See Texas Higher Education Coordinating Board (THECB).
Core Curriculum	Core curriculum refers to a set of courses (including American history; creative arts; English; government; language, philosophy & culture; mathematics; physical sciences; and social & behavioral sciences) as specified by the State of Texas and SACSCOC. Undergraduate students are required to successfully complete a minimum of 42 semester credit hours in the core curriculum to become eligible for a two- or four-year academic undergraduate degree and 15 semester credit hours to become eligible for an associate of applied science degree. These requirements are in addition to requirements associated with students' declared majors.
Core Curriculum Completer	A student who satisfies all component areas of the core curriculum is classified as core curriculum completer regardless of any other course work completed. Core curriculum completers are identified on the CBM-009 report. In the wake of the Texas Legislature adopting the HB 8 performance funding model, core curriculum completers are no longer eligible for state funding.
Core Requirements	Mandatory courses that students are required to complete to earn a degree.

Acronyms/Terminology	Description
Core Values	A set of values developed by the Collin College's administration and approved by its Board of Trustees in 2000. Collin's Core Values have become a guiding influence for the college. They include a passion for learning, service and involvement, creativity and innovation, academic excellence, dignity and respect, and integrity.
Co-requisite	Refers to courses that must be taken simultaneously during the same semester.
Cougar	Collin College mascot. The mascot is appropriately named "Collin."
Cougar Alert	Emergency notification system of Collin College. In the event of an emergency all Collin College students, faculty and staff are contacted via text, phone and email about the emergency and directions for what to do.
CougarWeb	Students use Collin College's Web portal, CougarWeb, to view classes and availability, register for classes, pay tuition, view financial aid status, access Collin Email, and more. Students need their usernames and passwords issued during the admissions process to log into CougarWeb located at https://cougarweb.collin.edu. Faculty and staff use CougarWeb to access personal or privileged information related to their employment or the College in general.
Course Completion Rate	Calculated by dividing the number of students enrolled in a given course, or set of courses on the last class day of a designated term by the number of students who were enrolled on the census date.
Course Drop Limit	Texas Education Code 51.907 Course Drop Limit Provisions: Students who enroll as an entering freshman or a first-time college student in undergraduate courses at any Texas public postsecondary institution are subject to the limit of six course drops. This includes any course a transfer student has dropped at another institution.
Course load	The number of courses or credits in which a student enrolls during a specific term.
Courtyard Center (CYC)	A Collin College instructional center located at 4800 Preston Park Blvd. Plano, TX 75093. The primary focus is noncredit workforce instruction. The site is abbreviated as "CY" in Banner.
Credit Hour	A unit of measure that represents one hour of instruction (50 minutes) in a specific course each week. It is applied toward the total requirements for a degree or certificate.

Dashboard	Dashboards are visual presentations of data from various sources to help users monitor and grasp the key points quickly. Dashboards organize and visualize data in a user-friendly and intuitive way to provide valuable insights to decision-makers based on accurate numbers in near real or real time. These visual representations of data usually consist of multiple pre-built widgets that are connected by aligning them on the same dashboard. Dashboards are interactive analytic tools used to monitor the performance. Many dashboards offer users the ability to drill-down into data or to aggregate or disaggregate data.
Data Base Dictionary (DBD)	Documents that contain detailed information about the elements in a data base including their locations, labels, formats, caveats, etc. IRO's Banner-related DBDs are posted in J:\IRO\Data Dictionaries.
Degree Audit	An advising tool that helps students know which required courses remain for them to successfully complete to earn a specific award. Collin College currently uses CougarCompass as its primary student-accessible degree audit tool. The ZogoTech data warehouse provides degree audit resources for staff and administrators.

Acronyms/Terminology	Description
Degree Plan	The list of courses required for a specific award.
Degree-Seeking Student	Students enrolled in courses for credit who are recognized by the institution as seeking a degree or certificate based on the student's declaration of a major.
Desk Review	Refers to the analysis of data and information submitted by a postsecondary institution to the THECB for the purpose of assessing some aspect of the institution by state authorities. Based on the desk review, the THECB determines whether an institution and/or its programs meet standards set by the THECB. The desk review does not involve a visit by state authorities to the college unless issue(s) are identified during the desk review that can only be resolved by visiting the college.
Developmental Education (DE)	Disciplinary groupings of remedial courses designed to prepare high school graduates and other adults with college-level knowledge and skills when they are not prepared to succeed at that level.
DigiTex (formerly the Virtual College of Texas [VCT])	DigiTex (https://digitex.org/home/), initially known as the Virtual College of Texas, was established in 1998 as a mechanism for inter-institutional online course sharing across the state. Online courses that originate at participating Texas postsecondary institutions are available to students enrolled at any other Texas postsecondary institution without students at the receiving institution needing to enroll at the provider institution. Collin College participates in DigiTex.
Dignity Initiative	The Dignity Initiative is a multi-year effort adopted by Collin faculty to educate the campus community about the specific elements of gender violence and to empower community members with specific action steps to end gender-based oppression. IRO supports the Initiative by administering post-event surveys and generating reports to assess the effect of the Initiative on student participants.
Directory Information	In compliance with the Family Educational Rights and Privacy Act (FERPA) of 1974, Federal Law 99-380, information classified as "Directory Information" may be released to a qualified individual or an organization that files a written request with the Registrar without the consent of the student. This information includes the student's name, address, telephone number, date and place of birth, major, field(s) of study, participation in officially recognized activities/sports, weight/height (for athletic team members only), dates of attendance, most recent previous educational institution attended, and degrees and awards received. A student may restrict the release of directory information. For more details, see the Collin catalog.
Discipline	An area of academic study.
Distance Learning	Instruction offered via cable television, Internet, satellite, videotape, or other means to students who are separated from the instructor by time or space. Courses offered via these modalities have a designation of "IT" in Student Information System.
Dual Credit (High School Dual Credit or HSDC)	The Texas Higher Education Coordinating Board (THECB) defines dual credit as a system in which an eligible high school student enrolls in college course(s) and receives credit for the course(s) from both the college and the high school. Dual credit courses may be taught on the high school campus by an approved instructor, on a college campus, or online. Dual credit may consist of either academic or technical courses.

Earned Hours	The number of credit hours a student has successfully completed. This includes all developmental, transfer, college-level, and non-traditional courses.
Economic Impact Study	An Economic impact study is undertaken every few years to measure the economic impact created by Collin College on the community and the benefits Collin College generates in return for the investments made by its students, taxpayers, and the society. It estimates the total dollars, jobs, and incomes generated in the service area due to the contribution of Collin College. The most recent economic impact study was conducted in 2022 by Lightcast, a labor market analytics firm. Collin College's estimated economic contribution to the region's overall prosperity was over \$907 million supporting 11,552 jobs in Collin County. IRO worked with Lightcast to provide data for the Economic Impact Study.
Educational Intent	The intended educational objectives that a student has upon entry, or develops through interaction with an institution's programs, support services, and staff. This intent can include an array of educational objectives ranging from taking a single course or courses to improving a certain skill, transferring credits to a university, or earning an award. Intent can and often does change over time.
18/27-hour rule	State law dictates that students are allowed to enroll in a maximum of 18 SCH of remedial instruction at state expense or, if they are non-English speakers, they are allowed an additional 9 SCH in ESL instruction.
Employability (Career Readiness or Work Readiness)	A state of readiness or preparation for a student to move into gainful, productive employment related to their area of study. It generally refers to employers' perceptions based on experiences of hiring program completers (degree or other formal award).
Employer Satisfaction Survey	A questionnaire designed and used by Collin to assess the degree to which employers of Collin's workforce education graduates are satisfied with the District's preparation of its graduates for the workplace. This survey is administered periodically to employers who have employed Collin's workforce education graduates and whose contact information is available. The survey results are posted on IRO's intranet site.
Enrollment Count	Refers to the number of enrollments (seats filled) rather than the number of individual students enrolled; e.g., a student enrolled in one course would be counted once and a student enrolled in three courses would be counted three times for an enrollment count within a period of interest (which may be a term, a year, etc.).
Enrollment History	Formerly referred to as "Headcount Statistics" when it was published and distributed as term-by-term static enrollment tables. Historical enrollment data now resides in two places. 1) A Tableau dashboard referred to as "Census and End-of-Term Registration" (https://prod-useast-a.online.tableau.com/#/site/collincountycommunitycollegedistrict/workbooks/300751/views). It provides a series of tables and charts summarizing and comparing enrollment over five years including a variety of disaggregations. 2) A series of static tables on the IRO intranet site under the "Student Information" link (https://inside.collin.edu/iro/studentinfo.html) that provides historical enrollment, demographic, and program completion data for credit and non-credit enrollment.

Environmental Scanning	Part of strategic planning involves obtaining information about an organization's environment from a variety of sources to help decision-makers stay ahead of upcoming changes. Environmental scanning involves reading from and communicating with a variety of sources to identify trends, events, and emerging issues in the economy, society, education, politics, and other areas to catch indicators of change that may impact the institution.
ESL	English as Second Language. The ESL course(s) are designed to teach English to students whose native language is not English.
Excess Hours	May refer to at least two concepts. 1) Number of semester credit hours (SCH) attempted by students in associate degree programs at Texas two-year institutions or bachelor's degree programs at Texas public four-year institutions in excess of the degree plan. To determine excess SCH, all college-level hours a student attempted are summed. This does not include dual credit and developmental education SCHs. 2) Student are allowed a maximum of 18 SCH in developmental education courses or 27 SCH plus another 9 SCH in ESL instruction. Students who attempt developmental SCH beyond the 18/27-hour maximum are identified as having excess hours and could be subject to higher-than-normal tuition.
Exit Session	A meeting between the SACSCOC peer review team and the President/CEO of the institution at the conclusion of a site visit during which the SACSCOC peer review team summarizes its findings.
Express Course	Compressed courses which have different start and/or end dates from the standard semester-length courses. These courses cover the same material and are worth the same credit hours as their semester-length counterparts. These courses are identified in the student information system by their start or end dates.

FAFSA	Free Application for Federal Student Aid. In order to apply for financial aid from the federal government (including Pell Grant, Perkins Loan, Stafford Loan and work-study) students must fill out the FAFSA.
Fall Enrollment	The number of students enrolled in classes on the primary census date (12th day of class) in September. When making reference to enrollment, typically, fall enrollment figures are used.
Farmersville Campus	Farmersville Campus opened in March 2021. It provides convenient access to higher education facilities for the residents of Farmersville and northeastern Collin County. It is located at 501 S. Collin Parkway, Farmersville, TX 75442. The campus is abbreviated as "FVC" in Banner.
Feeder High School:	A high school within the Collin's service area.
FERPA	Family Educational Rights and Privacy Act of 1974. This is a federal law that protects the privacy of educational records of all students. The primary rights defined by the act are: the right to inspect and review the educational records; the right to seek to have records amended; and the right to have some control over the disclosure of information about the records. Collin can release directory information if the student has not restricted the release of such information.

FFTE, FTEF, or FTTE	Full-Time Equivalent Faculty is a measure of teaching activity. It is calculated in different ways depending on the purpose for which it is intended. FTEF is also known as Faculty Full-Time Equivalent or Full-time Teaching Equivalent (FTTE).
FICE code	A six-digit identification number assigned to institutions of higher education. FICE stands for Federal Interagency Commission on Education. The FICE code for Collin is 023614.
Field of Study	"Field of Study" curriculum refers to a set of prescribed courses that satisfy the lower division requirements for a baccalaureate degree in a specific academic area at Texas public universities. When a student completes a Field of Study requirements, Texas public universities are required by law to accept them as a group toward the institution's baccalaureate requirements. Field of Study awards are not fundable under HB 8.
Financial indicators	Financial data provided by an institution that allows THECB and SACSCOC to assess an institution's financial viability and to determine if the institution is operating with integrity in its financial functions.
First-Generation College Student	A student who is the first member of his or her immediate family to attend a college or university; neither of his/her biological/adoptive parents have ever attended a college or university.
First-Time Freshman (First-Time Entering Student)	An entering freshman who has never attended any college. Includes students enrolled in the fall term who attended college for the first time in the prior summer term. Also includes students who entered with advanced standing (college credits earned before graduation from high school).
First-Time Transfer-In	A student who has completed college-level work at another institution before enrolling at Collin College.
Fiscal Year (FY)	In Texas, post-secondary public institutions refer to a 12-month period beginning on September 1 of a given year and running through August 31 of the following year. It is identified by the last calendar year in the period. For example, September 2022 to August 2023 refers to FY2023.
Flexible-Entry (Flex) Course	Courses that begin after the census date of a given term and end by the end of the regular semester. Students who take Flex courses are not reported in the census CBM report for the given term; rather, they are reported in the following term as "Flex students."
Focus Group	A carefully planned group discussion designed to obtain perceptions about a defined area of interest in a nonthreatening environment. A focus group is moderated by a trained facilitator. Typically 8-15 people participate in a focus group.
For-Profit School	Education institutions that are privately owned and operated as a profit-making enterprises take their cues from investors rather than academic professionals or legislatures.
Freshman	A student who has completed fewer than 30 semester credit hours in a 60 or 120 semester credit hour program.
Frisco Campus	The Frisco Campus (formerly known as Preston Ridge Campus) opened in July 1995. It is the second largest campus of Collin College. It houses a new IT Center, an Institute of Hospitality and Culinary Education (IHCE), the National Convergence Technology Center (CTC), a conference center, and a university-style central quad. It is located at 9700 Wade Blvd. Frisco, TX 75035. It is abbreviated as "PC" in Banner.

FTE, FTES, or SFTE	Full-time Equivalent Students is a measure of instructional activity, and is calculated by dividing the total number of semester credit hours generated during a designated semester or year by a denominator that represents the number of credit hours for a full-time student (IPEDS and Collin's Headcount Statistics use 15 hours as a denominator, since that is the minimum required to complete an associate's or bachelor's degree within two or four years, respectively. The Common Data Set (CDS) uses 12 hours as a denominator to calculate undergraduate FTE, since that is the minimum enrollment required to qualify for federal financial aid.
FTIC	First-Time-in-College: any student attending any institution of higher education for the first time.
Full-time Student (FT)	At Collin a student is defined as full-time if s/he attempts 12 or more credit hours per 16-week semester, 6 or more credit hours in a 5-week summer semester, or 9 credit hours in a 10-week summer semester.

Gatekeeper Courses or Gateway Courses	Based upon the guidelines from Achieving the Dream (AtD), "gatekeeper courses are college-level classes that students are required to successfully complete before enrolling in more advanced classes in their majors. Therefore, they serve as a major roadblock for many students." Examples at Collin College are ENGL1301, MATH1314, PSYS2301, HIST1301, HIST1302, or SOCI1301.
GED	General Education Diploma. A high school diploma equivalency award is based on a student's ability to pass a standardized test.
Good Academic Standing	A student with a cumulative GPA of 2.0 or better.
Graduation Rate	A percentage based on a ratio calculated by taking the number of students in a given cohort who complete a degree or certificate within a specified period of time (numerator) and dividing it by the total number of students in the cohort (denominator).
Graduation Rate Survey (GRS)	The Graduation Rate Survey is a component of the federal Integrated Postsecondary Educational Data System (IPEDS). It collects data on graduation and transfer-out rates of full-time, first-time-in-college, degree-seeking students over a time period encompassed by 150% of normal time to program completion. Normal time-to-completion is one year for certificate programs, two years for associate's degree programs, and four years for baccalaureate programs. The GRS also provides the basis for calculating four-year average graduation and transfer-out rates for compliance with the federal Students Right-to-Know law.
Graduation Rate: 100%, 150%, 200%	The proportion of an adjusted cohort that graduates in either: • 100% of time: the normal time for program completion (typically 1 year for certificates, 2 years for associate's degrees, or 4 years for bachelor's degrees) • 150% of time: 1.5 times the normal time for program completion (1.5 times the duration of the certificate, 3 years for associate's degrees, or 6 years for bachelor's degrees) • 200% of time: twice the normal time for program completion.
Guidelines for Instructional Programs in Workforce Education (GIPWE)	GIPWE (ttp://www.THECB.state.tx.us/ctc/ip/GIPWE2003/) is a manual that provides guidelines to institution regarding state requirements for workforce education programs.

HB 8	House Bill 8, passed by the Texas legislature during its 2023 session overhauled the funding model for Texas public community and technical colleges. Prior to HB 8, funding was primarily a function of enrollment along with a minor performance funding component. With the passage of HB 8, all community and technical college funding became performance-based, driven by students attaining various thresholds related to credits earned, program completion, and transfer with upward funding adjustments for designated groups of students such as older students or economically disadvantaged students.
Headcount	Headcount refers to the number of distinct students enrolled in a course, program, institution, or other units of interest. Likewise, faculty or staff Headcount refers to the count of distinct faculty or staff members employed at a designated point in time where each individual is counted once only. See unduplicated and duplicated headcount below.
Headcount, Duplicated	A headcount in which a student is counted once for each enrollment. For example, a student enrolled in three courses would be counted three times within the period of interest (which may be course, term or year). Duplicated headcount is synonymous with the number of enrollments, and it represents the number of seats filled during a given time period.
Headcount, Unduplicated	An enrollment count in which each student is counted only once within a given time period regardless of how many courses s/he is enrolled in. For example, a student enrolled in three courses would be counted only once within the period of interest (which may be course, term, or year). This represents the number of distinct students served within the time period.
Honors Institute	Honors Institute at Collin College provides a challenging learning experience for students with advanced academic skills. A GPA of 3.5 is required for taking honors courses.
Hybrid/Blended Course	Course with a mix of campus-based and online learning. According to the Texas Higher Education Coordinating Board's revised definition, which went into effect on December 1, 2023, a hybrid/blended course is defined as "a course in which a majority (more than 50% but less than 85%) of the planned instruction occurs when the students and instructor(s) are not in the same place."

iCollin Virtual Campus	The iCollin Virtual Campus offers fully online and blended general education courses. Students can utilize the student services that a traditional campus provides but have the flexibility of engaging with Collin online. Students can apply for admission, register for classes, receive tutoring and take courses online. Location: Online. Administrative Offices are located at Collin Higher Education Center, 3425 Spur 399, McKinney, TX 75069. The campus is abbreviated as "VC" in Workday.
IHEs	Abbreviation signifying Institutions of Higher Education.
In-District Tuition	Tuition charged to Collin students who meet the State and institutional requirements for residency in Collin County.
In-State Tuition	Tuition is charged to Collin students who reside in Texas but do not meet the State and institutional requirements for residency in Collin County. These students pay in-state tuition which is lower than what non-Texas residents pay.

Institutional Credential Leading to Certification/Licensure (ICLC)	A new award recognized by Texas for community college funding under the HB 8 funding model that took effect in fall 2023. Institutions may award a credential for completion of an approved series of courses that represent achievement of an identifiable skill proficiency leading to certification or licensure. In high-demand disciplines, the course sequence must consist of at least 80 contact hours or 5 semester credit hours. In other disciplines, the course sequence must consist of at least 144 contact hours or 9 semester credit hours.
Institutional Effectiveness (IE)	Institutional Effectiveness is a systematic research-based approach to planning and evaluation used to demonstrate that the institution and its administrative units are accomplishing their intended purposes.
Institutional Response	An institution's written response to a SACSCOC external or on-site review team's recommendation(s).
Instructional Division	Collin College's primary instructional subunits. Instructional divisions managed by deans and report to Provosts.
IPEDS	Integrated Postsecondary Education Data System. It is a comprehensive data collection program managed by the National Center for Education Statistics (NCES) within the U.S. Department of Education. This federal reporting system is built around a series of surveys that provide institutional data for various areas of the institution, like enrollment, completions, faculty and staff finances, etc. IPEDS cycles run from July 1 through the following June 30 each year. There are three primary data collection windows and two ancillary collection points during each annual IPEDS cycle. The first ancillary window opens about August 1 and ends about August 31 (annual registration and IPEDS Header); The primary Fall window opens about September 1 and runs through the third Wednesday in October (Institutional Characteristics, Completions, 12-Month Enrollment). The primary Winter window opens about December 1 and runs through the first Wednesday in February (Student Financial Aid, Graduation Rates, 200% Graduation Rates, Admissions, Outcome Measures); the primary Spring window opens about December 1 and runs through the first Wednesday in April (Fall Enrollment, Finance, Human Resources, Academic Libraries); the final ancillary window opens about June 1 and ends about June 30 (submission of custom list of IPEDS national peer institutions).
IPEDS Year	July 1st of a given year through June 30th of the following year.
IRB	Under FDA regulations, an Institutional Review Board (IRB) is an appropriately constituted group that is formally designated to review and monitor research involving human subjects. In accordance with FDA regulations, an IRB has the authority to approve, require modifications in research (to secure approval), or disapprove research. The IRB serves the important role of protecting the rights and welfare of human research subjects. The IRB has specific forms to complete and submit prior to conducting research on human subjects. As per federal regulations, Collin's Institutional Review Board is comprised of a minimum of five members, including a mix of scientists and non-scientists. IRO has one ex officio seat on Collin's IRB. All IRO staff members are required to successfully complete the IRB training every three years.
IRO or IR	Abbreviation for Institutional Research (IR) or Institutional Research Office (IRO). At Collin College, it may also refer to the Institutional Research Team, a subunit of IRO. At present, the IR Team consists of a Director and a Research Analyst and has the primary responsibility for survey research and calendared and other ad hoc projects that do not fall within the purview of another IRO team. Other subunits within IRO include the Business Intelligence & Data Warehousing (BI&DW) Team, Enrollment Analytics and Reporting (EA&R), Institutional Effectiveness (IE) Team, and the Office Support & Student Evaluation (OS&SE) Team.

Job Fair	An event(s) organized by Career Services at Collin campuses to help connect students with potential employers, offering opportunities for internships, part-time and full-time jobs, and opportunities to explore career opportunities within the local region across various industries.
K	
Key Performance Indicator (KPI)	A quantifiable measure of performance over time for specific strategies, goals, or objective(s). They are used to monitor an organization's progress toward the attainment of strategic, master, financial, and operational plans, performance, or targets, especially compared to other organizations within the same sector. KPIs facilitate organizational progress and provide insights that help people across the organization make better decisions.
L	
Labor Market Information (LMI) System	A Web-based software platform that provides access to industry, employment, and wage data and projections for various geographical, occupational, and other disaggregations in an easy-to-use interface. JobsEq is an LMI developed and maintained by Chmura Economics & Analytics that is the primary tool of Collin's IRO.
LBB Performance Measures	Ten measures on which Texas public postsecondary institutions annually report to the Legislative Budget Board (LBB). The ten measures operationally define institutional performance relative to annual targets.
Learning Communities	Learning Communities mean different things to different institutions. At Collin College, the term refers to two or more courses blended around a common interdisciplinary theme to form one integrated class taught by professors representing both areas of study. The classes meet in blocks of time, equivalent to two classes.
Learning Outcomes	May refer to the course level or the program level. The learning outcomes are a set of expectations articulating the knowledge and skills students are expected to master to some specified degree by the end of a course or program completion. These outcomes are typically aligned with the goals and objectives of individual courses, programs, or the institution as a whole. All courses and programs approved by the THECB include a set of learning outcomes associated with them, but institutions are free to add additional expected learning outcomes to any course. The learning outcomes are intended to provide a basis for assessment of student learning at the conclusion of a course or upon completion of a program.
Licensure	Licensure is a formal affirmation of competence by a regulatory body within an employment field that is based on test/assessment performance. Licensure must be attained to obtain gainful employment within the field.
Limited English Proficiency (LEP)	Students whose native language is not English are required to take an exam to assess their level of proficiency with the language. Based on the exam's results, a student may be classified as limited-English proficient or as English proficient. The former students are directed into remedial English-as-a-Second Language courses to help them develop English proficiency that will enable them to succeed in college-level instruction. LEP students are reported as such on the CBM student reports.
Linked courses	Enrollment in a Collin College credit course through continuing education (CE) is referred to as a Linked course. Linked courses mix credit and non-credit (CE) students in the same learning environment, ensuring the same rigorous academic standards are met.

Lower Division Courses	Lower-division courses introduce students to an academic discipline. They provide an overview of foundational theories, concepts, and methods and may cover a great deal of ground in less detail than upper-division courses. All 1000- and 2000-level courses taught at Collin College are considered lower-division courses.
LRC	Learning Resource Centers (Libraries) are located at Collin's various campuses. Collin has seven libraries located at the following campuses: Celina, Farmersville, Frisco, McKinney, Plano, Technical and Wylie. The College also provides online resources for students.

Master Plan	A road map of an institution's future specifically related to facilities and infrastructure needed to support the College's mission and strategic plan. Collin's master plan focuses on decision-making, resource allocation, and infrastructure development in light of the institution's mission and priorities over a seven-year period. It is based on the assessments of the institution's strategic needs as well as opportunities and challenges foreseen by the institution's stakeholders. The Institutional Research Office helped develop and administer a Student Feedback Survey and a Faculty and Staff Feedback survey to obtain input on the development of the Master and Strategic Plans.
Master Plan Priorities	The overarching, multi-year, facilities- and infrastructure-related goals that comprise Collin Colleges master plan and that support accomplishment of Collin's mission and strategic plan.
Maymester	Formerly a condensed two-week term that ran between the end of spring and the start of summer semesters. It was discontinued as a distinct term and became two-week credit academic period (part-of-term) that technically is part of summer semester.
McKinney Campus	The McKinney Campus (formerly known as Central Park Campus) opened in 1986. This was Collin College's first campus. It is home to Collin's health sciences programs and home to the College's emergency and protective services programs. It is located at 2200 W. University Drive, McKinney, TX 75071. Its abbreviation is "CC" in Banner.
Mission Statement (Collin College)	Collin College's Mission Statement: "Collin County Community College is a student and community-centered institution committed to developing skills, strengthening character and challenging intellect." This statement is intended to provide the basis for all activity that occurs at the College, and forms the fundamental basis for SACSCOC's evaluation of the College's performance.
Mission Statement (IRO)	With input from the entire department, the IRO mission statement was revised in 2022. The department's current mission statement is: "We use data in all its varieties to conduct research, assessment, and planning to help people make informed decisions and achieve Collin College's mission." This statement forms the fundamental basis for the evaluation of the department's performance in the five-year service reviews.

NCBO	Non-Course-Based Option. NCBOs were remedial instruction options enrolled in by students who failed to demonstrate college readiness in reading, writing, or mathematics. Collin offered only mathematics remediation (NCBM) outside a semester-based course. It may have included boot camps, bridge programs, etc. With the introduction of college-level and remedial co-requisite courses, NCBO is being phased out at Collin College.
NCCBP	The National Community College Benchmark Project (NCCBP) was developed by the National Higher Education Benchmarking Institute at Johnson County Community College. NCCBP enables colleges to benchmark themselves against a set of other community colleges from around the United States against a large number of both credit and non-credit measures. NCCBP includes over 150 credit and 100 non-credit measures against which participating institutions can benchmark themselves.
Non-Degree Credential	A formal award other than a college degree or certificate, typically including certifications and licensure (with increasing attention to new types of awards, such as badges and other "micro-credentials").

Occupational Skill Award (OSA)	An occupational skills achievement award may be a credit program of 9-14 SCH or a workforce continuing education program of 144-359 contact hours. These awards meet a minimum standard for program length specified in the Federal Workforce Investment Act (WIA) but are too short to qualify as certificate programs on the Coordinating Board program inventory. Initially, these were referred to as Marketable Skill Awards (MSA), but the name was changed to avoid confusion with a later THECB initiative.
Off-Site Reaffirmation Review	Part of the SACSCOC accreditation process. An Off-Site Reaffirmation Committee (comprised of a chair and eight to ten members) meets in Atlanta, GA, to determine whether an institution is in compliance with the SACSCOC's core requirements and standards based on the institution's Compliance Certification report. It sends the institution its preliminary findings and compiles a report for each institution on its compliance that is sent to the On-Site Peer Review Committee.
OneLogin	OneLogin is a single sign-on and identity management tool for applications used by Collin. After logging in, the user will have single-click access to applications such as Canvas, Office 365, Workday, and many more applications based on permissions. Users are required to download the OneLogin Protect app to access Collin College online resources.
On-Site Reaffirmation Review	Part of the SACSCOC accreditation process. An On-Site Reaffirmation Committee meets at the institution undergoing review, and it undertakes a focused evaluation of the institution's QEP and any compliance issues that were not resolved after the off-site review. At the conclusion of the site visit, the On-Site Reaffirmation Committee submits a written report of its findings and makes recommendations.

ZogoTech	ZogoTech is a data analytics solution designed to provide institutions with actionable insights across the student experience to improve institutional performance and student success. It was adopted by Collin College in 2016 as its primary data warehousing and business intelligence solution. It is a secure, central data repository that integrates information extracted from the Banner Student System, the National Student Clearinghouse, and Canvas. Users log into ZogoTech (https://zogotech.collin.edu/) using a browser and their Collin credentials via CougarWeb. Users can select from among a variety of existing reports, develop their own reports, or request custom reports. In the Student Navigator module, users can create, monitor, and analyze data for specific student cohorts. (See Student Navigator.) All administrators and full-time staff have access to ZogoTech. Faculty members and part-time staff may request access to specific projects with their dean's approval.
