- Tuition reimbursement and sick leave pool: Gen was unable to meet with Dr. Matkin in December because the meeting was canceled. The meeting was rescheduled for January, but several cabinet members were out. The meeting has been rescheduled for February 7.

- Staff submission: Submitted by Rebecca Kleinman, Science Lab, Farmersville. Proposal summary: Create a district-wide initiative to foster diversity, equity, and inclusion (DEI) in addition to existing EEO policies. Identify stakeholders and add a Board Policy, website, and strategic goal to increase and support DEI at Collin College.

Gen: We do not currently have a diversity and inclusion officer or office. The floor is open for questions comments.

Christy: I definitely support this and expressed concerns in our recent survey submitted to Dr. Matkin to give feedback.

Pam: I feel like many of the things we do are check-the-box things, and we don't have a lot to make a difference or support people.

Stacy Bilich: What types of things do other organizations do to foster diversity, equity, and inclusion?
Gen: As Staff Council, if we decide that we want to pursue this idea, we will put together an ad hoc committee. The committee would research best practices in DEI that are utilized by other colleges. We would then put together an overview of what we would like to see and the rationale for why we need it. We would then present the proposal to Dr. Matkin, and the appropriate department would be responsible for initiating.

Diana Platt: I think this is being presented as a proactive program.

Gen: Yes, this would go above and beyond what we already do.

Christy: They would be proactive in giving us training on those biases and how to prevent them. Those departments are usually proactive. They will collaborate with other departments, to recruit and retain a diverse population, and to promote inclusion. It is very proactive versus reactive.
