position will be filled at the start of the next academic year. The new member will serve a two-year term.

 Revised: To maintain membership status, members may not incur more than three unexcused absences in an academic year. An unexcused absence is any absence not given at least the Monday prior to the Friday meeting. Excused absences will be made for those using FMLA, planned vacations, illness, bereavement, family emergencies, and work conferences. If three unexcused absences occur, the President will decide next steps for the staff member. If a staff member is dismissed due

to lack of attendance, their position will be filled at the start of the next academic year. The new member will serve a two-year term.
